Administrator Deluhery stated that it is \$2,025 per month for the life of the contract and stated this will come out of the IT budget.

Sheriff Lower stated that the fees are currently very far out of line and stated that the County is losing money daily.

Member Stahl questioned if there is a policy regarding how often fees are studied.

Administrator Deluhery stated that our policy states fees should be studied every three years.

Administrator Deluhery stated that there is roughly \$1,400,000 left in the account. He stated that this Resolution recognizes qualifying expenses for the remaining amounts.

Member Stahl stated that when the ARPA funds were originally released, they were set aside for building, maintaining, or upgrading, water and sewer and broadband. He stated that last year, they received a report from Broadband that there were 4,285 communities underserved in Tazewell County. He stated that he would be voting no on this because Broadband received zero funding from this.

Chairman Graff thanked Treasurer Clark and her office for all their work on this grant.
