RM-24-04 MOTION BY MEMBER MENOLD, SECOND BY MEMBER SCHNEIDER to approve contract extension with Tim Neuhauser/Envision Insurance

Member Rich-Stimson questioned if we would ever go out for bid again or just keep extending the contract.

Administrator Mike Deluhery stated that for a lot of vendors the County tries to have a longer established relationship for at least five years.

Presiding Chairman Harris stated that the County has saved \$328,000 switching to Envision and they have worked well with the Human Resources department.

Presiding Chairman stated that they are recommending a two-year contract extension.

Tim Neuhauser from Envision Insurance Group stated that his insurance agency represents the County's commercial, property and casualty insurance. He stated that for the last three years, they have

gone out to other insurance companies and had them bid on the coverage.

Member Graff questioned what the County's rate was for the first three years.

Human Resources Director Sue Webster stated that the rate for the first three years was \$28,000 annually and it will not go up.

On voice vote, MOTION CARRIED UNANIMOUSLY.
