The Zoning Board of Appeals makes all final decisions on Class B Special Use and Variance Requests, unless there is a lack of 4 concurring votes during deliberations. Upon a recommendation by the Zoning Board of Appeals, all Class A Special Use, Rezoning and Code Amendments proceed to the Land Use Committee and require a Final Decision by the Tazewell County Board.

Appeals: \$250.00

Less than 2 acres \$350.00 2 or more acres but less than 15 acres \$450.00 15 or more acres but less than 25 acres \$550.00 25 or more acres but less than 80 acres \$600.00

80 or more acres but less than 101 acres \$650.00 with an additional \$7.00 per acre more than 100 acres

Rezoning:

Less than 2 acres \$450.00 2 or more acres but less than 15 acres \$550.00 15 or more acres but less than 25 acres \$650.00 25 or more acres but less than 80 acres \$750.00

80 or more acres but less than 101 acres \$850.00 with an additional \$7.00 per acre more than 100 acres

Special Use Mobile Homes: \$350.00

Special Use Chickens/Fowl: \$300.00

Code Amendments: \$350.00

Tract Surveys: \$25.00 per lot for review by the Plat Officer

Preliminary Subdivision Review: \$25.00 per lot with a minimum charge of \$300.00

and a maximum charge of \$1,000.00

Final Plat - Subdivision Review: \$150.00 plus \$25.00 per lot and a maximum

charge of \$1,000.00

Subdivision Modification: \$200.00
